#### Mission Statement of the Museum

The Mission of the Daughters of Utah Pioneers McQuarrie Memorial Museum is to collect, preserve and display artifacts, photos and histories belonging to the Utah Pioneers who settled Southern Utah prior to 1900, and those artifacts, photos and histories which represent the Washington County communities. The donor-based collection represents the early local pioneer communities and serves as an educational research facility for both descendants of those early pioneers and the community.

#### **Board President's Message – Jeanine Vander Bruggen**

It has been interesting to return as President of the Museum Board after several years. Even though I have visited often, being on the premises frequently helped me appreciate more all the time and effort that has gone into maintaining the beauty of the Museum, while constantly finding ways to make it more efficient, adding new artifacts, and highlighting some of the very special items we have in the Museum.



While COVID19 continued to plague us most of the year, attendance has steadily increased. Docents have been faithful in keeping their commitments to serve, and the many, many wonderful handmade items donated by members have increased our revenue. Visitors are always looking for souvenirs of St. George and having beautiful labels that designate "made in St. George" has increased interest in purchasing the unique offerings.

We continue to promote our Museum as part of the Pioneer Corner in collaboration with the Pioneer Courthouse. Guests at both locations are encouraged to visit the two buildings which together truly give us added opportunities to tell the story of our history which is greatly needed with the rapid growth of our community.

I look forward as I serve you for this next year, and I expect to see us making continuous gains in the layout of the museum, highlighting the stories of the early settlers here, and reminding all who visit of the sacrifices required, not only of this area, but with all early settlers in the territory. We begin the upcoming new year with the installation of a Chairlift to assist those who have difficulty navigating our stairs. We cheer this long-awaited addition.

Join with me in moving the visibility of the Museum to a higher level so more can appreciate all who came before us.

#### History of Daughters of Utah Pioneers and the McQuarrie Memorial Museum

Daughters of Utah Pioneers (DUP) was organized April 11, 1901, under the leadership of Annie Taylor Hyde with 46 women, all of Utah pioneer descent. In September 1921, Washington County, Utah pioneer descendants, under the direction of Flora B. Horne, created their first Company, and immediately began collecting relics, photos and histories of pioneers who settled Washington County. The members were faced with the handicap of having no building to house or display relics. A drive was launched to obtain one of the historic buildings, but to no avail. Priceless relics were being destroyed.

In 1936. Josephine B. Pace corresponded with a childhood friend, Hortense McQuarrie Odlum, relating the dilemma faced by DUP members. Hortense responded, stating she would be happy to help erect a pioneer hall in St. George as a gift to the city of her birth. Hortense funded the \$17,500 required to construct a beautiful edifice. She secured an architect to design the building and worked with the Washington County Commissioners to get the land donated for the project. The entire city joined in celebrating the dedication of the building on June 17, 1938.

Then in 1985, the building was expanded through the efforts of Ferol McQuarrie Kincade Moore, another descendant of the McQuarrie pioneers, who upon visiting the Museum, recognized its crowded condition. Ferol helped secure the \$90,000 needed to double the size of the existing building and add a new roof to the entire building. The addition was dedicated in October 1985 at the annual District Convention of the DUP.

With the continuing support of the DUP members in Washington County who serve as docents, the Museum is open five days each week from 10AM to 5PM, except in December, when the hours are 11AM to 3PM. There is no admission fee. The Museum is operated through donations by members, visitors, and generous grants. All services rendered by Board, Staff and Docents are voluntary.

#### What is a Docent?

A docent's role is to be a guide to inform visitors about the museum exhibits. This is done through telling stories, sharing historical facts, or relating reminiscences. School children are taught through guided tours and offered an opportunity to "touch" certain objects. Docents ensure the collection of artifacts, photos, and histories is protected, order is maintained, and guests are welcomed. A docent may be the only introduction a visitor has with the history of the Utah territory, specifically the southern part of Utah, and the contribution early settlers made in building up the surrounding communities. Over 200 women volunteer as docents each year to keep the Museum open on a regular basis. In addition, a Core Docent serves each day to provide support and training.

#### Major Accomplishments June 1, 2021, Through May 31, 2022

With the loosening of restrictions due to the pandemic of 2020 and 2021, attendance is returning to a more normal level. Museum hours have returned to 10 AM to 5 PM, five days per week. Much progress has been made in accomplishing the goals of the Museum Board and staff. The building looks so clean and fresh, and many visitors comment on how nice it is to visit.

We were finally able to install a dumpster in collaboration with the Pioneer Courthouse to dispose of refuge more easily. Also, in collaboration with the Courthouse we designed a joint brochure and in doing so have increased the distribution throughout southern Utah and northern Arizona and Nevada at a reduced cost. We have been more effective with the use of social media in getting the word out about our events and activities. On May 18, 2022, the Museum Board became the proud recipients of the Daughters of the American Revolution's prestigious Historic Recognition Award, presented at the Washington West Company Convention. The Lawmen and the Muddy River Gang have been able to join us on the 3<sup>rd</sup> Saturday of each month in front of the Pioneer Museum for re-enactments.

All our planned capital improvements were completed in a very timely manner. Our thanks to all who worked so diligently to accomplish this.

  display.
- Created a new display in Room 4 of a working kitchen.
- Reviewed condition of spinning wheels and are determining what can be done to restore them.
